I hereby represent and acknowledge that I am aware of these risks and that they cannot be completely eliminated even with the utmost care. I acknowledge that when participating in any capacity, in an event sanctioned by the LRCA, the risk of these injuries is substantially increased, and I have a duty to use caution and diligence to reduce the risk of the injuries and damages mentioned above. I assume the risk of any injury to my personal property or of any bodily injury to me, including bodily injury resulting in death or permanent injury, as a result of an event sanctioned by the LRCA, and I hereby waive any right I may have to assert any claim for damages of any kind arising out of any such injury against the LRCA, its officers, director's, employees, agents, representatives, and its sponsors, or against any LRCA contestants, stock contractors, rodeo producers, bull fighters, an other contract personnel. I do further release and discharge all of the above mentioned persons and entities from any liability for any of the above described personal injuries and property damages which are incurred in connection with my participation in an event sanctioned by the LRCA. I will not commence or prosecute any claim for damages against any of the persons or entities released, and if I bring or prosecute any claim in breach of this agreement. I will pay all costs and expenses caused by my breach or which are incurred in connection with the enforcement of this agreement, including a reasonable amount for attorney's fees, and abide by all rules of the LRCA.
