WARNING: Under Louisiana law, an equine activity sponsor or equine professional is not liable for an injury to or the death of a participant in equine activities resulting from the inherent risks of equine activities, pursuant to R.S. 9:2795.3.

I/We hereby release, have convert not to sue and discharge the promoter, participants, rodeo association, sanctioning organization or any subdivision thereof, arena operator, arena owner, officials, other participants, any persons in restricted area, promoters, sponsors, advertisers, owners, lessees or premises used to conduct the event and each of them, their officers and employees, all for the purpose then in referred to as "Releases" from all liability to the undersigned, by/our personnel representatives assigns, heirs and next of kin for any and all loss or damage and any claim or demand on account of injury to the participant included, but not limited to, death whether caused by negligence of the "releasees," or otherwise while the minor is in or upon restricted area and/or competing, officiating in, observing, working for or for any purpose participating in the event.

The restricted area is defined as the arena, chutes, staging areas, approaches thereto and all walkways, concessions and other areas apparent to any such area where any activity related to the event shall take place.

I/We will inform and instruct the said minor participant that upon entering any restricted area the minor must continuously thereafter inspect such restricted area and all portions thereof which the minor enters and which he/she becomes in contact and I/We further warrant that the minor's entry upon such restricted area or areas and his/her participation, if any in the event constitutes an acknowledgement that he/she (minor) has inspected such restricted area and that he/she finds and accepts the same as being safe and reasonably suited for the purpose of his/her use, and he/she further agrees and warrants that if, at anytime, he/she is in or about restricted areas and if he/she feels anything is unsafe, he/she will immediately advise the officials of such and will leave the restricted areas.

The undersigned expressly acknowledges and agrees that the activities of the event are very dangerous and involve the risk of serious injury and/or death and/or property damage.

The undersigned parent(s) or legal guardian, for the minor participant (under age 18) agrees, to identify and save and hold harmless the "releasees," and each of them from any loss, liability, damage or cost they may incur due to the presence of the said minor in or upon the restricted area or in any way competing, officiating, observing or working for any purpose participating in the event and caused by the negligence of the "releasees," or otherwise.

The undersigned parent(s) or legal guardian, for the minor participant (under age 18), have read and voluntarily signs the minor's release and waiver of liability and indemnity agreement and further agrees that no oral representations, statements and inducements apart from the foregoing written agreement have been made.
